- Public safety and emergency response: This could include applications such as connected cameras for public surveillance, emergency notification systems, and real-time crime mapping tools.

ROC Grants should constitute the sole or primary source of funding for the proposed project, not serve as complementary funding for larger, more costly projects.

# DISABILITY RIGHTS

- Small Grants range from USD 10,000 USD 30,000 per year.
- Mid-Level Coalition Grants range from USD 30,000 - 50,000 per year.

The Disability Rights Fund and Disability Rights Advocacy Fund are grantmaking collaboratives that support organizations of persons with disabilities (OPDs) around the world to build diverse movements, ensure inclusive development agendas, and achieve equal rights and opportunity for all.

**Small Grants** support growth of a broader and more diverse disability movement to advance the CRPD and the SDGs at local levels.

Mid-Level and National Coalition Grants support advocacy for more inclusive laws, policies, and programs. Because of the importance of joint advocacy at national and sub-national levels, only coalitions of three or more organizations will be funded. Applicant organizations leading coalitions must be OPDs, while partners can be either OPDs or other civil society organizations active in the promotion of human rights. Coalitions led by umbrella organizations or federations may include member OPDs as partners, but must also include at least one outside organization to be eligible. Coalition grants support projects over the course of two years, with second-year funding contingent on progress in the first year.

Darwin Initiative Innovation is aimed at projects intending to test a novel approach that if proven could scale to deliver results for biodiversity conservation and poverty reduction.

## Horizon Europe 2021 - 2023

The European Commission has recently launched the Horizon Europe work programme 2023-24, as part of the broader Horizon Europe programme for 2021-2027.

Horizon Europe is the ambitious EU research & innovation framework programme for 2021-2027 that tackles climate change, helps to achieve the UN's Sustainable Development Goals and boosts the EU's competitiveness and growth. The programme facilitates collaboration and strengthens the impact of research and innovation in developing, supporting and implementing EU policies while tackling global challenges and supports creating and better dispersing of excellent knowledge and technologies. The work programme of Horizon Europe for 2023-2024 aims to support researchers and innovators in Europe to pursue breakthrough solutions for environmental, energy, digital and geopolitical challenges, contributing to the EU reaching its climate goals, increasing energy resilience, and developing core digital technologies.

This year, the programme includes targeted actions with key non-EU partners, including the second ever 'Africa Initiative II'. Building on the positive outcome of the Africa Initiative I of Horizon Europe Work Programme 2021-2022, the Horizon Europe work programme 2023-2024 includes ~25 topics under calls for proposals to boost EU-Africa cooperation on research and innovation (13 open calls and 10 forecasted calls), with a budget of around €300 million under Calls for Proposals that are particularly relevant for cooperation with Africa. The calls for proposals, enabling the implementation of the short-term and medium-term actions of the AU-EU Innovation Agenda, require or encourage participation of African entities. Topics range from climate change, rural innovation, sustainable food systems and sustainable energy to bringing European highly innovative SMEs to the forefront of African markets.

Deadlines: Kindly note that the call submission deadlines vary between March and April 2023.

The Council for the Development of Social Science Research in Africa, CODESRIA, with funding from the Carnegie Corporation of New York (CCNY) is implementing a research intervention to support senior academics in African Universities undertake research on various sub-themes related to the future of higher education in the continent.

#### The grant will be tenured for 15 months.

The overall focus of this intervention is to support research on systemic realities affecting African universities and the higher education space more generally. In designing this intervention, CODESRIA noted that the higher education space in the continent is strongly connected to prevailing socio-economic challenges like poverty, underdevelopment, insecurity and climate change. An appreciation of these broader contextual issues as they impact higher education will be necessary. Those submitting proposals for consideration should focus on the following sub-themes:

Higher Education in Africa and the SDGs, Digital transitions and alternative pedagogies for graduate education, Curriculum and graduate transition into the work environment, African universities and the national and global research eco-systems, The future of the social sciences and humanities in African universities, The changing nature of academic and scientific freedom in African Universities, The question of funding and implications for university missions and mandates.

A 5-10-page proposal synopsis indicating the specific theme/topic to be investigated, with a clearly articulated conceptual framing for the work to be undertaken and clearly linked to current literature on one of the sub-themes identified above. ## Call for Fellowships: Research into online gender based harassment



#### **Deadline**: Ongoing Opportunity

Code for Africa (CfA) in partnership with Jigsaw, is offering research grants and technical support for evidencedriven analysis into how malign actors coordinate harassment and complaints against African women journalists and fact-checkers across 21 African countries.

The research fellowships come with a financial stipend, along with access to CfA's in-house research desk, as well as forensic analysts, data scientists and open source intelligence (OSINT) researchers, and machine learning tools for social listening or data/network analysis. The research fellows will compile evidence about online gender-based harassment into substantive public research reports that shines new light on the actors, networks and motives behind the online harassment and how it undermines public participation of marginalised groups on the African continent.

#### Where will my research be published?

- Fellows' research output will be published with their home institutions, as well as on this site. CfA will also collaborate with research partners to identify and publish in relevant high-impact, mass-audience media or industry journals. Research can also be published as pre-print papers.
- Depending on the research output, and the report format, the fellows may present their findings at public events or on broadcast media (as guest speakers) rather than in print media. As a principle, CfA will strive for syndication or multiple publications, to maximise impact.

#### **Eligibility Criteria**

- Individuals or small teams that work in African countries, or that are affiliated with African-based partners can apply.
- All applications will be evaluated by an internal review committee.

## FULBRIGHT AFRICAN RESEARCH SCHOLARSHIP PROGRAM (ARSP) 2023

A The Public Affairs Sections of the U.S. Mission in Nigeria are pleased to announce the annual call for applications for the Fulbright African Research Scholar Program (ARSP) for the 2024/2025 academic year. The program offers senior faculty from select Nigerian universities the opportunity to conduct research or carry out curriculum development activities at U.S. academic or research institutions.

ARSP offers two categories of grants as follows. Applicants must indicate their grant category.

#### 1. **Research Grant:**

ARSP research grant offers senior faculty from select Nigerian universities or research institutes, opportunity to conduct research in any academic discipline at a U.S. academic or research institution for a minimum of three (3) months and a maximum of nine (9) months, beginning no earlier than August 2024 and no later than March 2025. Applicants for research grants must hold a doctorate degree or equivalent terminal degree in their fields at the time of application. Preference will be given to individuals who have at least three years of university teaching experience and a productive scholarly record.

#### 2. **Program and Curriculum Development Grant:**

ARSP program and curriculum development grant offers senior faculty or administrators from select Nigerian universities or research institutes, opportunity to conduct research in any academic discipline at a U.S. academic or research institution for a minimum of three (3) months and a maximum of five (5) months beginning no earlier than August 2024 and no later than March 2025. Proposals should be linked to professional duties and demonstrate how the scholar will use the knowledge gained to develop new courses, curricula, or other academic programs at the home institution. This grant is designed for university faculty or administrators with less experience and who may not have had recent access to research or instructional developments in their disciplines. A doctorate degree is not required, but applicants must hold a minimum of a master's or equivalent graduate degree at the time of application.

#### Grant Benefits:

The grant covers J-1 visa, round trip airfare to the U.S., a settling-in allowance, professional allowance, monthly stipend, housing allowance, books-and-supplies allowance, and computer allowance. The grant also covers basic university health insurance as a primary insurance coverage and the Fulbright ASPE health benefit as secondary coverage. The grant also covers dependent allowance and travel of one dependent if he/she will stay with the grantee for at least 80% of the grant period.

#### RESEARCH OF FOCUS

AirQo Project of Makerere University in partnership with the Air Quality Monitoring Research Group (AQMRG) from the University of Lagos and UrbanBetter Lab Innovation Africa, University of Pretoria, have launched a city-focused consortium to scale up participatory and evidenced-based approach to tackling air pollution across African cities.

This pioneering multi-region partnership is an Africa-led collaboration and emphasizes the need to strengthen regional networks for sustained collaborations and will enable the partners to co-develop solutions for improving capacity for air quality monitoring and management across five (5) countries in Eastern, Central, and Western Africa including Uganda, Burundi, Cameroon, Ghana and Nigeria.

The consortium is supported by the US Department of State, with an established history of pioneering continuous air quality monitoring in data-hungry cities through the US Embassies across Africa. This partnership will build a 'regional community of practice to convene air quality experts, decisionmakers, community groups, the private sector, and other air quality practitioners and stakeholders to create knowledge and develop best practices to:

- Improve air quality monitoring, modeling, forecasting, and data management;
- Expand awareness and understanding of air quality issues;
- Develop and implement air quality management frameworks and clean air solutions across scales.

In Sub-Saharan Africa, air pollution is known to be more deadly and costlier than malnutrition and unsafe water and recently HIV/Aids, and yet systems and deliberate policies to manage air quality are not fully established. Existing baseline data show that air pollution levels are over 10 times the World Health Organisation (WHO) annual guidelines across the participating cities, but designing tailored interventions would require a more high-resolution and continuous monitoring network.

Professor Engineer Bainomugisha, the AirQo Project Lead, and the consortium lead noted that the new funding collaboration is a big milestone for the African continent as it will not only improve the regions' capacity in air quality monitoring and access to air quality data but also strengthen cross-region air quality management collaborations in African cities.

"We will establish regional air quality management hubs through collaborations with the partners in order to improve capacity in air quality management across Africa. Cities need to start collecting air quality data so that they are aware of their own contribution to air pollution and put in place mitigation efforts," noted Professor Bainomugisha



. "Through this funding, we will not only accelerate expansion into new African cities but also work with cities to build clean air solutions and establish air quality management frameworks. These frameworks will enable increased access to air quality data and capacity among local authorities in more African Cities to raise awareness for action."

The University of Lagos Air Quality Monitoring Research Group (AQMRG) will be coordinating the West African Research Hub which will bring together researchers, policymakers and advocacy groups from Nigeria, Ghana and Cameroon.

'We are excited that this collaboration gives us the opportunity to champion participatory air quality research work in Nigeria and West Africa.' Dr. Rose Alani, the AOMRG lead noted. Dr Alani Rose further added that the consortium's biggest strength is having a multidisciplinary and muli-stakeholder group including Lagos State Environment Protection Agency, US Mission, Evidence Use in Environmental Policymaking in Nigeria (EUEPiN)

U.S Mission Air Quality Technical Working Group (AQTWG), University of Yaoundé, Cameroon, University of Burundi, Ghana Urban Air Quality Project (GHAir), Federal Ministry of Science, Technology and Innovation, Centre for Housing and Sustainable Development (CHSD), University of Lagos, Federal Ministry of Science and Technology (FMSTI), among many others; all with a shared vision for cleaner air for cities. Deo Okure, the consortium coordinator emphasised that the collaboration particularly advances new approaches to air quality monitoring and modelling while utilising a hybrid network of Lowcost sensors and reference monitors. A total of 65 locally developed lowcost sensors will be deployed in the cities of Lagos, Bujumbura, Accra, Yaounde, and one other city in

Uganda and will be supplemented by existing reference monitors installed in the respective U.S Missions. Cityspecific Machine Learning and AI models will be deployed to predict and forecast air quality while improving the quality of low-cost data.
