

Raw materials are becoming increasingly scarce. Their extraction and processing place an excessive burden on the earth through greenhouse gas emissions, biodiversity loss and water consumption. A transformation toward a significantly reduced raw material footprint is the societal consensus. This is the goal of circularity. Recycled and biogenic materials, prolonged product lifespans, refurbishing and repurposing are key to this.

#### What is funded?

The funding line 'Collaborative projects' is primarily aimed at the natural and engineering sciences. Participation from other fields is possible, if respective expertise is needed. Two to three researchers from different subfields with a common topic count as a collaboration. Funding is provided for original and practically relevant research problems towards closing raw material-product cycles. Topics for funding include amongst others bio-inspired material design, microbial and molecular conversion, valorization of complex waste streams, and recycling-friendly product design.

A second funding line for 'Practice transfer' is in preparation. Presumably, by the end of 2023 further details on this accompanying call will be announced.

# Population and systems medicine: responsive mode: programme

The Medical Research Council (MRC) is looking to provide funding to support a programme of research focused on population and systems medicine.

The population and systems medicine board (PSMB) funds research to unlock the complexity of human health and disease across the life course.

The funding remit includes population health and the impact of environmental factors including the social environment on health outcomes. Research focused on the physiology and pathophysiology of all the major organs and systems, with the exception of the brain and the immune system, is normally supported through our other research boards.

MRC is looking to fund research in areas including, but not limited to:cardiovascular, respiratory, musculoskeletal, gastroenterology, renal medicine and liver function, endocrinology and reproductive health, maternal health and the early origins of health and disease, nutrition, metabolic regulation, diabetes and obesity, trauma, acute medicine and surgery, inflammation in relation to disease processes and the resolution of the inflammatory response, medical sociology, lifestyle, socio-economic and behavioural impacts on health, health inequalities, population and disease related cohorts

## Quarterly Research Grant Funding Programme

Funding Amount: £50,000 to £2,500,000

Closing Date: 16-Oct-23

This programme primarily funds preclinical and clinical research focused on slowing, stopping, or reversing Parkinson's. They do not fund research which is directed at symptomatic relief. There are three strategic aims; they believe that if they deliver these, they are giving themselves the best chance of realising the goal of finding a cure.

#### **Priorities**


- Due to the urgency requirement, they prioritise research which has potential to translate into the clinic within five years.
- One priority is therefore to fund and support promising clinical trials. This includes funding for trials themselves and pre-clinical research to support potential trials.
- It can also include funding any other research supporting or accelerating clinical trials and their outcomes, including clinical trial design, research into exploratory outcome measures, cohort definition, patient stratification, genetic data collection (e.g. biobanking of samples), flexible bridging support (extension funding) for trials running into difficulties, screening libraries with appropriate assays, carrying out epidemiological studies, novel approaches to treatment or new methods of treatment delivery.
- More widely, the aim to cure Parkinson's (i.e. slow, stop or reverse) can include potential for preventing or delaying the onset of the condition, although prevention and delay alone are not priorities for Cure Parkinson's: they seek to cure those living with Parkinson's now.

# Strategic Opportunity Fund

This is a rapid response fund that can be accessed by women's organizations and their networks for the promotion and protection of women and girls' rights. It is designed to enable women's organizations and their networks respond promptly to rights violations as well as seize unanticipated opportunities to create change in the lives of women and girls in Nigeria.

The grant positions the Local Women's Rights Organisations (LWROs) to be nimble in responding to women and girls' rights issues in any location. Since project commencement, 19 organisations including non-project partners have benefitted from this fund.

Target Audience: Community people, Farmers, Akwa Ibom Women Cooperatives, Kano Youths, Partners Stakeholders, Women Farmers etc.

#### **Eligibility Criteria**

If you have been in the NGO world for quite a while, you will agree that winning grants is not just about bank credit alerts. There are processes that spans across proposal development, review, preselection, due diligence, final selection, Work Plan development, and Work Plan Approval, before granting finally happens. These processes could take months, and sometimes years, but imagine all these including implementation, reporting, and funds retirement happening in seven (7) days? Yes, 7 days - they present to you WVL Nigeria project Strategic Opportunity Fund (SOF).

# Diversity in Science Grants

**Amount:** \$50,000

Closing Date: 6<sup>th</sup> December 2023

The Biochemical Society's Diversity in Science Grants (BSDCG) scheme provides grants of up to £500 to individuals, groups, charities or not-for-profit organisations.

BSDCG helps create and support a representative scientific community with our Diversity in Science Grants.

These grants are available to any individual or group with a project that will support and address issues relating to inclusion and diversity in science. You do not need to be a member of the Society to apply and you don't need to be based in the UK; these grants are open to applicants from any country.

This year we are particularly interested to receive applications that address one or more of the areas identified as priorities by our community in our 2023 survey:

- Neurodivergence in the workplace and improving access for those with disabilities;
- Supporting women in biochemistry and those with caring responsibilities;
- Communicating EDI data metrics for the biochemical community;
- Representation and diversity at conferences, events and on editorial boards;
- Recognition and promotion of the visibility of minority scientists.

Previous recipients of any of our grants are welcome to apply for funding from this scheme.

# DARWIN INITIATIVE



**AMOUNT:** £100,000 and £600,000

**DEADLINE**: open

Round 29 sees the continuation of Darwin Initiative Main, now in its 30th year. Darwin Initiative Main invites applications for environmental projects between £100,000 and £600,000.

You need to apply online for Round 29 Darwin Initiative projects through the Flexi-Grant Application Portal.

Round 29 of the Darwin Initiative include the following schemes:

- Darwin Initiative Main Stage 1 closed, Stage 2 by invite only
- Darwin Initiative Extra now open
- Darwin Initiative Capability & Capacity now open
- Darwin Initiative Innovation now open

Additional material that you will be required to complete as part of your application can be downloaded from Flexi-Grant.

Darwin Initiative Extra will continue under Round 29 for projects between £600,000 and £5m. Darwin Initiative Extra is intended for projects that are on a clear scaling pathway: building on good evidence from smaller projects to demonstrating the potential to scale further by completion and delivering strong results for biodiversity conservation and poverty reduction. Darwin Initiative Innovation is aimed at projects intending to test a novel approach that if proven could scale to deliver results for biodiversity conservation and poverty reduction.

# Horizon Europe 2021 - 2023

The European Commission has recently launched the Horizon Europe work programme 2023-24, as part of the broader Horizon Europe programme for 2021-2027.

Horizon Europe is the ambitious EU research & innovation framework programme for 2021-2027 that tackles climate change, helps to achieve the UN's Sustainable Development Goals and boosts the EU's competitiveness and growth. The programme facilitates collaboration and strengthens the impact of research and innovation in developing, supporting and implementing EU policies while tackling global challenges and supports creating and better dispersing of excellent knowledge and technologies. The work programme of Horizon Europe for 2023-2024 aims to support researchers and innovators in Europe to pursue breakthrough solutions for environmental, energy, digital and geopolitical challenges, contributing to the EU reaching its climate goals, increasing energy resilience, and developing core digital technologies.

This year, the programme includes targeted actions with key non-EU partners, including the second ever 'Africa Initiative II'. Building on the positive outcome of the Africa Initiative I of Horizon Europe Work Programme 2021-2022, the Horizon Europe work programme 2023-2024 includes ~25 topics under calls for proposals to boost EU-Africa cooperation on research and innovation (13 open calls and 10 forecasted calls), with a budget of around €300 million under Calls for Proposals that are particularly relevant for cooperation with Africa. The calls for proposals, enabling the implementation of the short-term and medium-term actions of the AU-EU Innovation Agenda, require or encourage participation of African entities. Topics range from climate change, rural innovation, sustainable food systems and sustainable energy to bringing European highly innovative SMEs to the forefront of African markets.

Deadlines: Kindly note that the call submission deadlines vary between March and April 2023.

#### Important Notes:

• The budgets, project periods, deadlines and requirements regarding consortia and eligibility vary from one call to the other and must be consulted carefully with OSP before working on the call.

#### INDIVIDUAL AND TEAM FELLOWSHIP OPPORTUNITIES

STIAS provides and maintains an independent 'creative space for the mind' to advance the cause of science and scholarship across all disciplines. It is global in its reach and local in its African roots, and values original thinking and innovation in this context. No restriction is placed on the country of origin, discipline, or academic affiliation when STIAS considers a fellowship invitation. It encourages the cross-pollination of ideas and hence gives preference to projects that will tap into, and benefit from, a multi-disciplinary discourse while also contributing unique perspectives to such a discourse. This interaction is fostered by inviting individual fellows or project teams where each team member is evaluated individually.

The STIAS programme comprises projects which are entirely self-generated and proposed by applicants, as well as projects and programmes initiated and led by STIAS, typically with select partner organisations (see Initiatives). STIAS fellows are expected to be resident at STIAS for the duration of a fellowship, with no academic obligations other than pursuing the proposed <u>research</u> project. The only other obligations are to share in the discussion over lunch which is served daily at the STIAS Wallenberg Research Centre, and to participate in the Tuesday and Thursday STIAS fellows' seminar where fellows in turn present their work to other fellows and invited academics from the local community.

STIAS accepts and welcomes proposals for team projects (typically three to five participants). Team members are usually accommodated in a large office with five workspaces and adjoining seminar room and lounge.

Funded projects will incorporate science, storytelling, and/or education, and must align with one or more of the Society's five focus areas: Ocean, Land, Wildlife, Human History & Cultures, and Human Ingenuity.

#### **Funding Information**

- **Level I Grants:** Funding requests at this level can be up to USD \$20,000.
- Level II Grants: Funding requests at this level can be up to USD \$100,000, but smaller requests will be accommodated and will not be more or less competitive.

#### What they Fund?

- Bold, innovative, transformative work
- They fund individuals working on projects in science, conservation, storytelling, education, and technology that align with one or more of the focus areas.
- And they don't just support their incredible work. They actively seek to help them network, connect, and learn with National Geographic and each other, empower them with cutting-edge tools, technology, and training, and further their impact and recognition through the storytelling.
- Methods and/or means of work must be ethical, sensitive, and align with the National Geographic Society Code of Ethics
- You may submit a proposal as the project leader for only one National Geographic Society grant at a time.
- You must submit a final report and media from any previous National Geographic Society grants for which you were the leader before applying to lead a new project.

# Mental Health Award: Understanding how anxiety- and trauma-related problems develop, persist and resolve

Early-career researcher, Established researcher, Mid-career researcher,

Where your administering organisation is based: Anywhere in the world (apart from mainland China)

Level of funding: £4 million Duration of funding: 5 years

This award will fund researchers to investigate the causal mechanisms through which brain, body and environment interact over time in the development, persistence and resolution of anxiety- and trauma-related disorders. Knowing more about these mechanisms will help us find better ways to identify these problems and intervene at an early stage.

The funding is to drive a transformative change in our ability to intervene as early as possible in the course of anxiety, depression and psychosis, in ways that reflect the priorities and needs of people who experience these problems. This call will fund research that advances scientific understanding of the causal mechanisms through which brain, body and environment interact over time in the development, persistence and resolution of anxiety- and trauma-related disorders.

To be eligible to apply, applicants must address at least one of the following two priorities.

#### 1. Research that considers multiple levels of explanation

The causes and solutions of mental health problems are likely to involve a combination of biological, psychological and social factors. Integrated approaches are therefore crucial to understanding the causal mechanisms of mental health problems.

We are therefore looking to fund research that examines questions at more than one level of explanation (for example, molecular, cellular, systems, cognitive, behavioural, social, environmental or societal). This may involve using different experimental models (for example, organoid and rodent models) and human participants; however, this is not a requirement.

#### 2. Research in low- and middle-income countries

Of the more than 300 million people living with an anxiety-related problem globally, an estimated 79% (238 million) live in low-and middle-income countries. Despite this, research into anxiety-related problems in these countries has been underfunded, with less than \$2 million spent on anxiety each year, compared to over \$17 million spent on depression. Without a better understanding of how these problems develop, persist and resolve in these countries, we will not be able to progress towards our vision of a world in which no one is held back by mental health problems.

We are therefore looking to fund research within and/or across low- and middle-income countries, to better understand how different contexts may impact the trajectory of anxiety-related problems. Read the full list of low- and middle-income countries.

- The fellowship has two tracks i) a wet-lab track focusing of end-to-end protocols for nextgeneration sequencing of pathogens; and ii) a drylab track with a focus on public health bioinformatics data analytics, interpretation, and reporting.
- The fellowship program aims to support technical experts and future leaders in public health pathogen genomics and bioinformatics in Africa.
- Training led by continent-based educational and professional subject matter experts
- Training at State-of-the-art facilities across the continent
- Multilingual fellowship program

#### The fellowship program has the following objectives:

- To train pathogen genomics and bioinformatics workforce to improve outbreak detection, investigation & disease surveillance in Africa
- To contribute to strengthening the prevention, preparedness, surveillance, and control of infectious diseases while supporting the implementation of Africa's New Public Health Order
- To contribute to knowledge and technology transfers and capacity building within and between African Union Member States

#### Potential candidates and host institutions:

- We are anticipating at least 25 fellows for the 2023 cohort
- 15 host institutions across Africa. Applicants should provide evidence of the host institution's agreement to accept the fellow for the duration of the fellowship period. Africa CDC and ASLM will support fellows to identify host institutions.

#### UNILAG Empowers Early Career Researchers with Grant Writing and Research Commercialisation Skills



The Research Management Office (RMO), under the leadership of Professor Timothy Nubi, held a grant writing and research commercialisation workshop for early researchers between Monday, October 23 and Tuesday, October 24, 2023 at the Tayo Aderinokun Lecture Theatre, UNILAG, Akoka. The workshop with the theme "Building Grant Writing and Research Commercialisation Skills – A Practical Approach" kicked off with the Deputy Vice-Chancellor (Academics & Research), Prof. Bola Oboh welcoming participants, noting that the workshop was set up to build capacity in terms of writing for and winning grants among early career researchers.

The two-day workshop taught early-career researchers about practical steps to submitting competitive research proposals, clarifications about grants applications, legalities, contracts, who can lead a team as a principal investigator, Central Research Committee (CRC) grants, administrative costs of grants, budgeting, etc. The interactive sessions provided participants with opportunities to ask questions and clarify grey areas on issues relating to finding research funding, patenting, commercialization and licensing of inventions, as well as developing a comprehensive budget for their projects.

# **HREC**

The University of Lagos **Human Research Ethics** (UNILAG HREC) now has a Central Office at the Research Management Office, Akoka Campus. The Office has the same mandate as the Idi-Araba HREC Office, and brings all services for ethical clearance to your door-step at Akoka Campus. This further reiterates our commitment to have a one-stop Office at the RMO. The HREC Office has the following mandates:

- Verify that the rules and processes of the university regarding research ethics adhere to both national and international standards.
- Create institutional review and research ethics Standard Operating Procedures (SOP) and policies for the University;
- Educate the university's staff and students about conducting ethical research and conducting ethics reviews by offering seminars, workshops, materials, and other resources
- Provide administrative support to all researchers applying for ethical clearance

The **Research Ethics Office** ensures that research conducted by University researchers/faculty and students, complies strictly with institutional policies as well as with global best practices. UNILAG HREC consists of the Institutional Review Board (IRB), which reviews research involving human subjects.

# **ACUREC**



We are also happy to inform you that the University's Animal Care and Use Committee (ACUREC), which reviews and grants ethical clearance to research studies involving animals is likewise housed in the Research Management Office.

In essence, prior to research involving animal(s) can be undertaken, it is imperative to seek reviews of the project's ethical considerations and obtain approval from UNILAG ACUREC. Kindly note that it is a violation of global and national ethical laws governing handling of or use of animals in research without seeking and obtaining ethical approval. In essence, no research, teaching or testing that involves the use of animal should commence before ethical approval by the Committee. We are committed to ensuring that researchers do not dabble into unanticipated problems or complications for neglecting national regulations and policies governing animal care and use.
